

PRECAUTIONARY STATEMENTS

HAZARDS TO HUMANS AND DOMESTIC ANIMALS: CAUTION: Harmful if absorbed through skin. Avoid contact with eyes, skin, or clothing. Prolonged or frequently repeated skin contact may cause allergic reactions in some individuals. Wash thoroughly with soap and water after handling and before eating, drinking, chewing gum, using tobacco or using the toilet. Remove contaminated clothing and wash clothing before reuse.

FIRST AID

DIRECTIONS FOR USE:

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

USE RESTRICTIONS:

• Except when applying directly to animals, do not allow people or pets to enter the treated area until sprays have dried or vapors, mists and aerosols have dispersed and the treated area has been thoroughly ventilated • Do not apply this product in a way that will contact any person or pet either directly or through drift. Keep people and pets out of the area during application • Do not remain in treated area. Exit area immediately and remain outside the treated area until aerosols vapors and/or mists have dispersed • Only spray in well ventilated areas • Not for use on meat or dairy animals, poultry or horses or foals intended for slaughter • Not for use in farm structures or buildings housing food producing animals or poultry or in milk rooms • Do not allow product to contact animal's eyes, nose, mouth or sores during application • Do not use on foals, puppies or kittens under 12 weeks old • Remove or cover exposed food and drinking water before application • Remove or cover dishes, utensils, food processing equipment and food preparation surfaces or wash them before use • Application is prohibited directly into sewers or drains, or to any area like a gutter where drainage to sewers, storm drains, water bodies or aquatic habitat can occur. Hold container upright, with nozzle pointed away from you and press actuator button, spraying as directed.

TO TREAT HORSES:

To protect horses from attacks of stable flies, horse flies, deer flies, house flies, horn flies, mosquitoes and gnats, spray about 3 seconds on each side being careful to spray legs, belly, neck, back and sides. Cover eyes when spraying face, or spray on sponge or cloth and apply to face as a wipe. Brushing animal after applying will bring out a bright sheen.
