

PRECAUTIONARY STATEMENTS HAZARDS TO HUMANS AND DOMESTIC ANIMALS

CAUTION: For use on animals only. Not for use on humans. Harmful if swallowed. Causes moderate eye irritation. Avoid contact with skin, eyes or clothing. Wash thoroughly with soap and water after handling and before eating, drinking, chewing gum, using tobacco or using the toilet. Remove contaminated clothing and wash clothing before reuse.

FIRST AID

IF SWALLOWED:

IF IN EYES:

• Hold eye open and rinse slowly and gently with water for 15-20 minutes • Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye • Call a poison control center or doctor for treatment advice

IF ON SKIN OR CLOTHING:

• Take off contaminated clothing • Rinse skin immediately with plenty of water for 15-20 minutes • Call a poison control center or doctor for treatment advice

ENVIRONMENTAL HAZARDS

This product is extremely toxic to fish. To protect the environment, do not allow pesticide to enter or run off into storm drains, drainage ditches, gutters or surface waters. Applying this product in calm weather when rain is not predicted for the next 24 hours will help to ensure that wind or rain does not blow or wash pesticide off the treatment area.

FOR USE ON HORSES:

Clean horse's face, ears and other areas to be treated by brushing or with a soft damp cloth. Remove cap from bottle. Apply around animal's nose, eyes, ears and mouth. May also be used as a spot treatment where flies gather. Avoid direct application to eyes, nose and mouth. Replace cap after use. For initial treatment, apply daily for 2 to 3 days. Then apply every 10-14 days as needed to maintain control. Do not use more than 1-2 ounces per application.

STORAGE & DISPOSAL

Do not contaminate water, food, or feed by storage or disposal. **Storage:** Store in a cool, dry place. **Disposal:** If empty: Non-refillable container. Do not reuse or refill this container. Place in trash or offer for recycling if available. If partly filled: Call your local solid waste agency for disposal instructions. Never place unused product down any indoor or outdoor drain.
