HAZARDS TO HUMANS AND DOMESTIC ANIMALS:

IF INHALED:


- Move person to fresh air.

DIRECTIONS FOR USE:

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

GENERAL PRECAUTIONS & USE RESTRICTIONS:

- · For use on horses only.
- The preferred application time is at the end of the day once the animal is ready to rest. If used during the day, allow Wipe N' Spray to dry before turn-out of the horse.
- Avoid applying Wipe N' Spray if you expect the animal to be outdoors during a heavy rain.
- Except when applying directly to horses, do not allow adults, children or pets to enter until sprays have dried.

It provides a protective hair coating against flies while imparting a high sheen to the hair when brushed out. 1 to 2 ounces per head per day gives adequate protection. Apply by either soft cloth or fine spray mist. Only a light application is needed. Avoid using an excessive amount. Do not wet skin.

USE TO WIPE ON:

Use only for direct application to horses, indoors or outdoors in close proximity to the stable. First, brush animal to remove dirt and dust. Moisten (but do not wet to the point of dripping) a soft cloth and rub over the hair. It is best to apply by rubbing against hair growth. Give special attention to legs, shoulders, shanks, neck and facial areas where flies are most often seen. After application, brush out thoroughly to bring out bright sheen on the coat. Repeat daily as needed.

USE AS A SPRAY:

WIPE N' SPRAY" may be used only for direct application to horses, indoors or outdoors in close proximity to the stable, or indoor premises (stables).
